Field of Dreams Student Parking Permit Info 2019-2020

All **Field of Dreams** parking permit requests must include the following:

- **Current Driver's license**
- **Vehicle registration and expiration date**
- **Vehicle insurance information**
- **Student Agreement Registration form**

(The Community Services Department will make copies & all information will be kept on file in the office.)

Your **Field of Dreams** parking permit must be visible in the vehicle at all times; permits must be either on the vehicle dash board or hung from the vehicle rear view mirror.

All illegal parked vehicles will be towed at the owner's expense.

Rules & Regulations

- All forms must be accompanied by copies of the **Current Vehicle Insurance** (showing the expiration date and the student's name as the insured), **Current Vehicle Registration & Current Driver's License**.
- Parking Permits are available and issued from **September 1, 2019 to June 12, 2020, September 1, 2019 to January 10, 2020 and/or January 13, 2020 to June 12, 2020 or November 15, 2019 to April 15, 2020.**
- Parking Permits issued are valid for parking Monday thru Friday, until 2:45pm **ONLY**.
- **The payment must be made to reserve the space.** If payment has not been received by the start of that time frame, **Field of Dreams Inc.** will assume you no longer want the parking spot and the spot will be filled from the waiting list.
- Forms and payments may be dropped off at the **Ingram Senior Center 1 Sally Sweet Way, Salem, NH 03079.**
- **Make checks payable to the Field of Dreams.**
- Failure to pay will result in loss of parking permit.
- Parking Permits **CANNOT** be transferred to other students.
- Vehicles must be parked within the lines appropriately.
- Parking Permits will be revoked if information is not up-to-date or missing. You must notify **Field of Dreams, Inc.** (603.943.3390) immediately with any changes regarding your vehicle.
- Reckless driving such as speeding, peeling out, disobeying traffic signs, etc. will result in loss of parking privileges.
- An Administrative fee of \$5.00 will be charged for Replacement Parking Permits.
- As long as you have paid your parking fees and are up-to-date with all required information, you will have first right of refusal to park next school year. However, you must request your name be added to the **2020-2021** list by the end of the school year (May-June).
- **The Field of Dreams is NOT responsible for any damage to vehicles or lost/stolen items.**
